TARIFF UPDATE

Northwestel Inc. Tariff Notice 1021
Special Assembly # 1 Layer 2 Ethernet WAN

NOTE: Effective date – May 15, 2018

This tariff application was submitted to revise Special Services Tariff CRTC 3010 Item 756 - Special Assembly # 1 Layer 2 Ethernet WAN service, to correct an error on the tariff page.

SPECIAL SERVICES TARIFF

Item 756 SPECIAL ASSEMBLY #1 LAYER 2 ETHERNET WAN SERVICE

A. General

This service is provided pursuant to an agreement between a specific customer and Northwestel with a defined number of sites and speed level commitment (Initial Speed Level Commitment) from the customer. This service provides 12 customized point-to-point Layer 2 Ethernet WAN links and associated equipment between 13 terrestrial sites in the Company’s serving area. The initial circuit speed level at each site ranges from 20Mbps to 1000Mbps (depending on the site). The customer has the option to increase speed levels at each site based on additional monthly recurring fees as specified below.

Sites are divided into three categories as per agreement with the customer. These include Bands 1A, 1B and 2.

B. Terms and Conditions

A three-year initial contract term applies. At the end of the initial three-year term, based on mutual agreement, the service will be provided on a month-to-month term basis.

Provided that there is no inconsistency with the terms and conditions set out in this tariff, the services in this tariff are also subject to the terms and conditions provided for in Private Wire Service CRTC 3003, Item 1124, Ethernet Wide Area Network (E-WAN) Service. Where the terms or conditions set out in this Special Services Tariff differ from the Retail E-WAN Service Tariff, Item 1124, the terms and conditions of this Special Services Tariff will apply.

Customer may upgrade speed levels at Band 1B sites by increments of 100 Mbps at the rate specified below. The maximum total monthly fee for Band 1B sites will be \$20,000 for a maximum bandwidth of 1,000 Mbps

Customer may upgrade speed levels at Band 2 sites by increments of 10 Mbps at the rate specified below. The maximum monthly fee for Band 2 sites will be \$12,000 for a maximum bandwidth of 100 Mbps.

Upgrades beyond the Initial Speed Level Commitment are dependent on facilities being available.

C. Rates

One-time Capital Contribution:	\$ 138,500
Initial Speed Level Commitment Monthly recurring:	\$ 141,950

Upgrade rates:

Band 1B Sites: upgrades for each 100 Mbps:	\$ 2,000
Band 2 Sites: Upgrades for each 10 Mbps:	\$ 1,200

Note at locations at Band 1B where initial configuration is 50 Mbps, the customer may upgrade to 100 Mbps for an additional \$1525 per site above the initial configuration monthly recurring rate. Additional upgrades will be in increments of 100 Mbps as described above.
