**Introduce Business and Residential Cable Internet 100 to Norman Wells**

This tariff application was submitted to revise General Tariff CRTC 3001 Item 1737, Mackenzie Valley Terrestrial ADSL and Cable Internet Services, to introduce Business and Residential Internet 100 to Norman Wells.

**GENERAL TARIFF**  
**TERRESTRIAL INTERNET SERVICES**

**Item 1737 MACKENZIE VALLEY TERRESTRIAL CABLE and ADSL INTERNET SERVICES (MVTCAIS)**

**1. General**

- a. The following tariff provisions the rates terms and conditions for retail Cable and ADSL Internet services for those communities served off the Mackenzie Valley Fibre Link (MVFL) in the Northwest Territories. These communities include; Fort Simpson, Wrigley, Tulita, Norman Wells, Fort Good Hope and Inuvik. MVFL is a fibre facility owned by the Government of the Northwest Territories.
- b. Definitions, Business and Residential Classification, Classification of Technology, and Conditions that apply to this service are the same as those listed in General Tariff 3001 Terrestrial Cable and ADSL Internet Services, Item 1735. Where any of the terms or conditions listed in Item 1735 is inconsistent with this tariff, the terms and conditions of this tariff will apply.
- c. Service Availability  
This tariff applies to communities listed in Item 1737.1.a. Cable Internet services listed below apply only to Norman Wells. Service is subject to the availability of suitable facilities. Not all the service package offerings or infrastructure may be available in all service locations, or communities. Customers should contact Northwestel to determine package availability.
